



**NON-INSURED HEALTH BENEFITS PROGRAM:  
MEDICAL SUPPLIES AND EQUIPMENT PRICE FILE FOR THE ATLANTIC REGION**

To NIHB enrolled MS&E providers,

This letter is to inform you that the Non-Insured Health Benefits (NIHB) Program, Indigenous Services Canada, has implemented changes to remove the prior approval requirements and establish maximum prices for certain bathing, toileting, lift, transfer, and mobility aids.

Effective June 18, 2018, NIHB no longer requires prior approval from enrolled MS&E providers in Atlantic for eligible items identified in the price file table below.

Providers will be required to keep the following information on file:

- Prescription from a physician or nurse practitioner
- Manufacturer product code #, Make/model of the equipment
- Occupational therapy or physiotherapy assessment report or recommendation if available
- Copy of any third-party coverage (e.g. workers' compensation, private insurance, etc.)

Providers must ensure the client meets the following conditions for a manual wheelchair:

- The client is not a full-time wheelchair user (since full-time wheelchair users require a more advanced chair);
- The client is not transferring to a long term care facility; and
- The client is not palliative (as NIHB will fund a rental if this is available).

If the client does not meet the conditions above, a prior approval is required and providers will need to submit the request to the Atlantic regional office.

Providers are encouraged to confirm client eligibility for the item(s) prior to dispensing by contacting Express Scripts Canada at 1-888-511-4666 or the regional NIHB office at 1-800-565-3294.
