

### NEW INFORMATION

#### Wound Care Price File

On September 11, 2017, NIHB implemented the Wound Care Price File for select dressings of different types and sizes. For selected dressings, a PA is not required within the set annual maximum quantity of units and price per unit. A PA is required when the maximum annual quantity or price per unit is exceeded.

For example, a total annual maximum quantity of 30 Alginate dressings (either the 5 cm X 5 cm size, or 10 cm X 10 cm size, or a combination of these sizes), up to the maximum price (\$6.65 and \$16.10 per unit), can be claimed in a one-year period without a PA.

Below is the list of new item numbers and pricing for wound care dressings within their individual category.

Providers are expected to retain the documentation (prescription and wound care assessment) to support the request, as these may be requested for claims verification.

For PAs received before September 11, 2017 for items within the Wound Care Price File, providers should continue to use the coding as listed in the active PA authorization. For all subsequent claims, providers should use the new item numbers listed above.

For wound care supplies that are not included in the table, or are over frequency, please send a PA request to the regional office.

### New Item Numbers

The NIHB Program has created new item numbers for certain services and items. The following new item numbers are now in effect and are to be used when submitting prior approval (PA) requests to the regional office or claims to Express Scripts Canada.

For PAs for compression stockings received before September 11, 2017, providers should continue to use the item number(s) listed in the active PA authorization. However, providers should use the new item number(s) listed above for all subsequent claims.

### Hearing Instrument Practitioners - Recommendations

As of September 11, 2017, the NIHB Program will accept recommendations from hearing instrument practitioners (HIP) for audiometric tests and hearing equipment and supplies for when performed on adults of 18 years of age or older. This applies only in provinces and territories where the practice of HIP is regulated, where this activity is within their scope of practice and where items can be dispensed independently and in accordance with all appropriate acts and regulations that oversee the delivery of hearing services.

### Catheter Coverage

Effective August 1, 2017, the NIHB Program has changed its frequency guideline for intermittent catheters to a maximum of 4 catheters per day or 360 catheters per three-months.

For regular intermittent catheters, a maximum price of \$1.66 per catheter has been established, and the PA requirement has been lifted. For specialized catheters (for example a hydrophilic or Coudé catheter), a new benefit code 99401154 has been created, with a maximum price of \$3.00 per catheter. PAs continue to be required for these specialized items.

PA requirements will also apply for coverage requests above the new price and frequency guidelines.

### REMINDERS

#### Provider Agreements – When to Inform Express Scripts Canada of Changes

To process claims, Express Scripts Canada requires that all certifications (certificate, license and permits) and affiliates (staff) be listed on the provider Agreement. It is important to note that when a provider has an additional certification, they are required to sign a new Agreement because of the specialisation. As for changes to affiliates (staff), a revision of the existing Agreement is accepted.

#### Adding a Specialty/Certification after Registration:

When providers have a new license, certificate or permit, they must inform Express Scripts Canada of this change before submitting claims. Please complete a new provider agreement available at: [provider.express-scripts.ca/documents/Medical\\_Supplies\\_and\\_Equipment/Forms/English/Medical\\_Supplies\\_and\\_Equipment\\_Provider\\_Agreement.pdf](http://provider.express-scripts.ca/documents/Medical_Supplies_and_Equipment/Forms/English/Medical_Supplies_and_Equipment_Provider_Agreement.pdf).

The new provider Agreement should therefore include all relevant specialties and be submitted along with a copy of the appropriate certificate (for PRO1, PGO1 and PGO2) or diploma (for ORT1, ORT2, PRO3, PRO2, OXY, RES and AUD). Providers can send their documentation to Express Scripts Canada by fax or mail, see last page for coordinates.

**Maintaining the List of Affiliates (Staff):**

Providers who retain affiliates and/or contracted staff to assist with client files are reminded of the privacy considerations under section 8 – Records and Privacy in the Medical Supplies and Equipment Provider Agreement (Agreement). Express Scripts Canada and Health Canada staff can only communicate with the registered provider and staff listed in the Agreement.

To add any new name(s) of affiliate(s) and/or contracted staff to their profile, the provider is required to update their Agreement with Express Scripts Canada. This is done either by completing **section B of Appendix C** if the individual(s) is/are employed by the provider, or **section F** if the services are sub-contracted to a separate organization.
