Bismuth in Tablet and Suspension (Pepto-Bismol)

Effective January 3, 2017, bismuth products (Pepto-Bismol) in tablet and suspension form will have a frequency limit. The maximum amount will be 8 tablets per day for 14 days or 120mL per day of the liquid for 14 days. The NIHB Drugs and Therapeutics Advisory Committee recommended the change in listing status following the review of clinical evidence for bismuth. Evidence of efficacy was only found for the treatment of *H. pylori* infection for up to 14 days. Please note that the NIHB Program covers a full range of antibiotics and proton pump inhibitors to treat *H. pylori* infection. A full listing of medications is available at: health.gc.ca/dbl.

Naloxone Reimbursement *REVISED*

NIHB has added naloxone ampules, vials and nasal spray as open benefits. To support access to these naloxone products, NIHB will reimburse these naloxone products when prescribed or recommended by pharmacists in accordance with the Quebec provincial legislation.

The list of open benefit naloxone added to the NIHB Drug Benefit List (DBL) is as follows:

Medical Assistance in Dying

The NIHB Medical Assistance in Dying (MAiD) formulary provides coverage for clients eligible for MAiD in accordance with provincial/territorial regulations. Providers billing drugs and medical supplies and equipment (MS&E) for MAiD must call the Drug Exception Centre (DEC) and indicate they are seeking prior approval (PA) for the MAiD formulary. A copy of the MAiD prescription will be required.

Please note: MS&E items required to administer MAiD drugs will **not** be subject to regional office approvals – these items can be billed as a single claim under the pseudo-DIN MS&E for MAiD listed below.

Updates to Extemporaneous Mixture Policy

Back Order Items and Compounding

Providers who are preparing a compound to replace a commercially available product which is on back-order do not require a PA. The claim must be submitted using the corresponding miscellaneous pseudo-DIN. Providers are required to maintain documentation demonstrating the commercially available product was on back-order at the time of dispense.

Compounds with Diclofenac

Compounds with diclofenac as an ingredient require a PA and will be reviewed on a case-by-case basis.

Reminder: the compound must not duplicate a commercially available product.

List of Eligible Bases for Compounds

Uremol and CeraVe have been added as eligible topical compounds only. See below for a complete list of eligible non-medicinal bases:

- CeraVe cream/lotion
- Cetaphil
- Cliniderm
- Cocoa Butter
- Cold cream
- Compound tincture of benzoin (Friar's balsam)
- Dermabase
- Dilusol

- Lassar's paste
- Lubriderm
- Mineral oil
- Petrolatum (Vaseline)
- Uremol cream/lotion
- Zinc oxide creams/ointments

Powders for compounds

A list of powders for compounding that do not require a PA are now eligible for reimbursement when used to compound topical products.

The following powders are eligible without a PA when mixed with open benefit external lotions, creams or ointments that contain a medicinal ingredient. The powders are not eligible when mixed with the non-medicinal bases (as listed above).

- Menthol (in strengths of 0.5% or greater)
- Camphor (in strengths of 0.5% or greater)

The following powders are also eligible without a PA when mixed with open benefit external lotions, creams or ointments, or with an eligible base:

- Hydrocortisone powder (in strengths greater than 0.5%)
- Salicylic acid powder
- Miconazole powder
- Ketoconazole powder
- Nystatin powder
- Clotrimazole powder
- Sulfur powder
- Bethamethasone powder

Faxing Claims

In exceptional circumstances when submitting manually is required, pharmacy providers can fax original NIHB claim forms for processing to Express Scripts Canada. If preferred, providers can continue submitting claims by mail.
