NIHB HEALTH PROVIDER INFORMATION KITS

The content of NIHB Newsletters is also considered part of the Health Provider Information Kits, so please keep a copy with your kit.

*Please note that if you downloaded a new NIHB Health Provider Information Kit between June 23 and July 21, 2006, your kit contains incorrect information in the Provider Audit Section. Please visit the website to download a corrected version. We apologize for any inconvenience this oversight may have caused.

THIRTY DAYS TO SUBMIT ELECTRONIC DATA INTERCHANGE (EDI) CLAIMS

CDAnet and Réseau ACDQ registered providers can now submit claims to the NIHB Program using the EDI system within 30 days of the date of service. After this period, the provider must submit the claim manually to FCH.

NIHB FORMS

Please note that, effective immediately, all requests for packages of NIHB DENT-29 forms must be sent directly to First Canadian Health. Please fax a completed *Dental Form Supply Requisition* to **416-480-6610**.

Most forms associated with the program, including the NIHB DENT-29 form, and other NIHB program documents, are available for download from the NIHB website. Visit the 'Resources and Forms' section under 'Health Provider Information' at:

Please remember that the NIHB DENT-29 form is still mandatory for:

Pay client claims
Client reimbursements

☐ Claims payable to a third party

REPEATED/EXTENDED RESTORATIVE SERVICE

Repeated or extended restorations completed within a two-year period require documented rationale in the client's chart. As stated in the NIHB Dental Health Provider Information Kit:

"Replacement of restorations within a two (2) year time frame is subject to audit and reviews by the Regional Dental Officer/Dental Consultant and requires a written rationale."

Note that this requirement refers to restorations replaced by the same dental practitioner or by another practitioner working in the same office or group of practitioners.

PREDETERMINATIONS AND POST APPROVALS

Providers must submit requests for predetermination (PD) and post approval (PA) to their FNIHB Regional Office.

Requests for PD and PA submitted to FCH will be returned to the provider unprocessed.

NEW PROVIDERS AT ESTABLISHED PRACTICES

When a new dental practitioner joins an established practice, they must register with the NIHB Program to be able to submit claims for payment. Registration with CDAnet does not automatically confer NIHB eligibility.

REVERSING EDI CLAIMS

Corrections to claims submitted electronically must be completed on the same day as the original claim submission. To have a claim reversed or adjusted at a later date, make the correction on the applicable NIHB Dental Claim Statement and submit it to FCH for adjustment.

RADIOGRAPH REQUIREMENTS

Please remember that radiographs are not required when submitting manual claims to FCH for processing. Radiographs are only required for predeterminations and post approvals submitted to a FNIHB Regional Office.

NIHB DENTAL BENEFITS FOR CHILDREN

First Nations and Inuit children must be registered and have their own identification number in order to receive funding for dental benefits. Dental claims submitted with a parent's identification number will not be processed.

To register a child:

- ☐ Eligible First Nations clients should be referred to their Band Office or the Registration Services Unit of the Department of Indian and Northern Affairs Canada (INAC) at (819) 953-0960;
- ☐ Inuit residing in the Northwest Territories and Nunavut should be referred to their respective territorial Department of Health and Social Services;
- ☐ Inuit residing outside of the Northwest Territories and Nunavut should be referred to the nearest FNIHB Regional Office.
