**NON-INSURED HEALTH BENEFITS PROGRAM:
MEDICAL SUPPLIES AND EQUIPMENT PRICE FILE FOR THE ONTARIO REGION**

To MS&E registered providers,

This letter is to inform you that the Non-Insured Health Benefits (NIHB) Program of Indigenous Services Canada is implementing changes to remove the prior approval requirements and establish maximum prices for certain bathing, toileting, lift, transfer, and mobility aids.

Effective May 1, 2018, NIHB no longer requires prior approvals from Registered Providers in Ontario for eligible items identified in the included price file (see below).

Providers will be required to keep the following information on file:

- Prescription from a physician or nurse practitioner
- Manufacturer product code #, Make/model of the equipment
- Occupational therapy or physiotherapy assessment report or recommendation if available

Providers must ensure the client meets the following conditions for a manual wheelchair:

- The client is not a full-time wheelchair user (since full-time wheelchair users require a more advanced chair);
- The client is not transferring to a long term care facility; and
- The client is not palliative (as NIHB will fund a rental if this is available).

Please note, for items requiring coordination of benefits with the Assistive Devices Program (ADP), such as a wheeled walker or manual wheelchair, the provider may claim the portion not covered by ADP directly to Express Script Canada up to the maximum indicated in the NIHB price file. The amount claimed should not exceed 25% of the ADP listed price.

If the client does not meet the conditions above, a prior approval should be submitted to the Ontario Regional Office.
